

**VILLAGE OF CARPENTERSVILLE
BOARD OF TRUSTEES
REGULAR BOARD MEETING
June 1, 2021**

Board Meeting Location – Village Board Room, Village Hall, 1200 L.W. Besinger Drive, Carpentersville, IL 60110

The regular meeting of the Village Board of Trustees was called to order at 7:00 p.m. Those present for roll call were Village President Skillman, and Trustees Garcia, Malone, Sandoval, Frost, and Vela. Also present were Village Manager Johnson, Attorney Stewart, Village Clerk Mastera, Fire Chief Schilling, and Police Chief Hoey.

The Pledge of Allegiance was led by President Skillman.

An invocation was led by Ms. Lou Ness.

- President Skillman said that Ms. Ness walked from Rockford, IL to Washington D.C. and is someone he knows from way back.

PROCLAMATIONS, CONGRATULATORY RESOLUTIONS, AND AWARDS –

- A. Proclaiming June 2021 as Pride Month

President Skillman read the proclamation proclaiming June 2021 as Pride Month in the Village of Carpentersville.

APPOINTMENTS, CONFIRMATIONS, AND ADMINISTRATION OF OATH –

- A. Swearing-in of Patrick Hoey as Carpentersville Chief of Police

Village Clerk Mastera gave the oath of office to Chief Hoey. Chief Hoey then introduced his daughter Tabitha and son Ethan, and other family and friends who attended the meeting. He thanked the staff for being welcoming and helpful. He thanked Manager Johnson and the Village Board for having the confidence in him for this position.

President Skillman thanked the officers in attendance and reiterated the Board's support for them as well.

Chris Kious (Kane County Board Member District 23/Kane County Forest Preserve President)

- Mr. Kious said a Bee Blitz will be occurring on Saturday, June 19th at 8:00 a.m. at the Dixie Briggs Fromm Illinois State Nature Preserve. During this event people can help locate and photograph bees for research. He said research is done by the University of Illinois to study pollinators.

- He said the enlargement of the parking lot at Raceway Woods will begin on June 14th. It should expand it from 26 parking spots to 60+ parking spots.

REPORTS OF THE MANAGER AND STAFF –

Administration Update - Manager Johnson

- He reminded people that on Saturday, June 12th at 9:00 a.m. there will be a Special Board meeting to discuss and hear presentations about the Huntley Square Development. He said the meeting will be held in the Public Works Training Room. He stated the agenda and backup material will be sent out prior to the meeting and will be posted on the website.

- He said the State Legislative Session ended this morning and they passed the budget. He said some funds may be available for projects, so he is working with Public Works staff to make sure

they have a list of projects ready. Additionally, he said Carpentersville will now only be split between two districts, instead of three. He pointed out Representative Suzanne Ness who was in attendance, and the corresponding senator is Senator Dewitte. The other is Representative Anna Moeller and Senator Cristina Castro. He said this will help give Carpentersville a little bit better representation at the state level.

- He said the final state budget did not cut the Legislation Distribution Funds which represents a little over 10% of the Village's budget.

- He said the trailer bill to the original police reform legislation passed and had language that cleaned up some of the more problematic items in the original bill.

Trustee Garcia recused himself and exited the room at 7:14 p.m.
